Provider Access Policy Statement

Barnhill Community High School – Careers Strategy 2024-2025

Vision

"Every student is in a position to make informed, realistic and sequential decisions about their futures."

Aims

This policy statement aims to set out our school's arrangements for managing the access of education and training providers to students for the purpose of giving them information about their offer. It sets out:

- Procedures in relation to requests for access
- The grounds for granting and refusing requests for access
- Details of premises or facilities to be provided to a person who is given access

Statutory Requirements

Schools are required to ensure that there is an opportunity for a range of education and training providers to access students in years 8 to 13 for the purposes of informing them about approved technical education, qualifications or apprenticeships. This includes a minimum of 6 encounters with technical education or training providers to all pupils in years 8 to 13

Schools must also have a policy statement that outlines the circumstances in which education and training providers will be given access to these students.

This is outlined in section 42B of the [Education Act 1997](#).

This policy shows how our school complies with these requirements.

Student Entitlement

All students in years 8 to 13 at Barnhill Community High School are entitled to:

- Find out about technical education qualifications and apprenticeship opportunities as part of our careers programme, which provides information on the full range of education and training options available at each transition point
- Hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships, e.g. through DLD and workshops such as the Global academy events, assemblies and taster events
- Understand how to make applications for the full range of academic and technical courses. Supported by our connection with the Educational Development Trust

Management of provider access requirements

Procedure

External providers who wish to have access to students must identify the following criteria

- Align with our school views and ethos – Together achieving our best
- Must offer an opportunity to support student's pathway, beyond the support within school.
- Have a proven track record of working with students to ensure they are in the best possible position to succeed.
